The Authority is participating with the Manatee County Housing Finance Authority in its 2010 single family mortgage revenue bond program. Beginning February 3, 2010 the Manatee program is making \$5M available on a first come, first served basis until November 2010 for the origination of FHA/VA/RHS 30-year fixed rate, first mortgage loans on a first come, first served basis to qualified homebuyer applicants in Palm Beach County through the participating lenders listed on the following page.

Borrowers will be required to have a minimum FICO score of 600. The current first mortgage loan interest rate is 5% with no origination or discount points; customary lender fees will apply as disclosed on the HUD-1. The maximum income limits are a) \$90,480 for a 1 and 2 person household and b) \$105,560 for households of 3 or more persons. The maximum single family home price is \$452,548.

The Housing Finance Authority of Palm Beach County is offering a 30-year down payment/closing cost assistance second mortgage loan under this program in an amount not to exceed 4% of the first mortgage loan (increase effective 4/9/2010 retroactive to the start of the program) amount with simple interest at 3% per annum due upon maturity, sale, refinance or repayment of the first mortgage loan, or if the borrower receives a federal tax credit refund under the American Recovery and Reinvestment Act. First time homebuyers will be required to complete an approved homebuyer education course prior to loan closing. A list of providers is attached. Please note that some providers do not charge for this service so you are encouraged to contact each provider regarding fees, if any.
